## DISTRICT 1 MEETING SYNOPSIS

# September 25-26, 2015 - "What if..."

Our District 1 Leadership meeting took place on September 25-26, 2015 in Middleburg Hts., Ohio. District Leaders, Staff, and Area Leaders from the Carolinas, Michigan, Ohio, Ontario, and Pennsylvania were present. In addition to our couple-couple prayer partner time, Area, District Leadership, Staff, NAR, and Interfaith Reports; peer-to-peer discussion time; and worship together; our meeting focused on "The Power of Prayer and Positivity."

For the 25 days leading up to the meeting, board members participated in a daily 3 part prayer challenge project. The 3 areas of focus were our ministry responsibilities, our marriage relationship, and ourselves as individuals. The key questions that each person answered to begin the challenge were: "what are the greatest challenges I face in my areas of responsibility in LME, what are the greatest challenges I face in my marriage relationship, and what are my greatest personal challenges. After answering the questions, each person prayed daily about these areas of their lives (throughout the month of September) laying each before the Lord and listening for His direction. All were asked to take notes from the insights of their meditations and prayers. At different times throughout the meeting we met in couple-to-couple, small group, and large group for prayer and discussion of the different areas of focus. Kasts led the wrap up.

The topic of same-sex and non-married couples wishing to attend or showing up at LME Weekends was again addressed as per discussion at the last NAR meeting. Simplified, the discussion results were that first and foremost all individuals and couples are to be treated with love and respect, and that pre-Weekend calls (vs. email/USPS contact only) are encouraged to avoid surprises at the registration table on Friday night of the Weekend. The Board drafted and adopted a couple of simple response/policy documents which are included as bullet points below:

#### <u>A simple response to same-sex couple Weekend inquiries & Applications:</u>

We're so sorry; we're an organization designed only for heterosexual married couples. If you wish, we can give you a copy of our policy statement and references to organizations that may better serve your relationship needs.

- <u>Lutheran Marriage Encounter Policy Regarding Weekend Participation Eligibility:</u> Lutheran Marriage Encounter weekends are designed to strengthen the marriage of a man and a woman. The program is not designed for other marital or non-marital relationships. We are licensed under World Wide Marriage Encounter, and our license limits us to serving heterosexual, monogamous couples on our weekends.
- <u>Same-Sex and/or Non-Married Couples' Programs/Websites</u>: Couple Enrichment – <u>http://www.couple-enrichment.com/</u> These weekend-long "intensives" are given by married therapists and are held in Orangeville, Ontario. They are open to all couples, married or not, heterosexual or not.

**Heart to Heart** – <u>www.heart.mn.cx</u> or <u>www.hearttoheartmn.org</u> (information as of Fall, 2015); "Inclusive" since 1994, their programs value and welcome all committed couples: same-sex and opposite sex, married and unmarried.

#### Power of Two - <u>www.poweroftwomarriage.com/</u>

An online "membership" costing \$18/month, which any couple (there are single memberships too) can use to develop relationship resources.

Relationship Journey – <u>www.relationshipjourney.com</u> Programs developed by a marriage specialist for individual couples. These are resources, not events.

Marriage Mansion – <u>www.marriageencounteronline.org</u> Materials online to be used at any couple's convenience. Complete DVD and printed information available.

The Prorated WE Cost document and WWME Invitation to Mission Summary were also discussed.

We work hard with Leinicke Group to keep email church addresses current (we ask for a list of those that bounced/rejected and research new ways to connect). We aim to send one more email to churches for each Weekend, either before the eblast or after, as a reminder.

A local e-newsletter "Connections" has gone out 3 times since the last report, highlighting immediate next dates and events and referring occasionally to GLM resources (which we HOPE have now been updated for Ohio). In late November one of these Connections encouraged donations, and was based on Ed & Emily's letter.

The APT (Area Planning Team) has been holding steady (one changeover on Prayer Chain coordinators), committed and faithful. Two "newer" couples have become regular at KYRAP events and may be asked to join. We have tried to involve "one more" couple to help with events, and this is working well.

Sadly there is nothing Interfaith to report beyond our continued willingness to help the local BME clergy to write to the CPO outline; local Roman Catholic community is not responsive to our communications.

Sadly our presenting strength decreased with the untimely death of Lynn (V Jeff) Goggins, who had presented first set a few times while in seminary and were intending to rewrite as clergy. When we have a Weekend with hearing-impaired couples, we bring in a fourth "presenting" couple (BME's Ron V Mary Jo Mohlmaster). Currently there is no one actively discerning presenting.

2015's pattern has become our annual goal: to hold at least one self-pay w/e, one "traditional" w/e, and one "other" non-residential experience, for which we are actively seeking a host. We aim to provide an enrichment/fellowship/reunion after each M.E. Weekend, and to provide personal follow-up to each newly encountered couple done by the presenters for that particular W/E, and to continue a variety of events throughout the year.

Since Lynn's death, the Goggins are obviously not able to present, although Jeff expressed an interest in continuing in the ministry, which will not be ruled out.

#### <u>High Points</u>:

**Post Weekend event**: A great event was held last fall with 6 long-time supporter couples of PA Marriage Encounter spending a weekend in a huge house on the lake in Deep Creek, Maryland. Relationships were strengthened, and we hope this will result in the planning of some post-Weekend activities.

**Weekend applications:** Our April Weekend in Lancaster, PA, as of 2/18/2016 only has 2 openings left. Lancaster was a new location last year—this seems to suggest to us again that branching into new areas can bring in increased applications. Also we encountered 19 couples at the Pocono Weekend last fall which again suggests that holding Weekends off-season at "destination" locations can bring in more applications.

#### <u>Concerns</u>:

**Prayers requested:** Prayers are requested for our Registration Couple, Larr and Denise Etzler. Besides Denise fighting cancer, Larr has been laid off from his job and has not been able to find a new one. They are in the process of losing their home and moving in with his mother. Also our Lancaster Prayer Couple wife, Dennean Ludwig, is still struggling with a crippling illness that is still undiagnosed.

**Regarding post-Weekend activities**: Because our couples attending a given Weekend are so spread out geographically, we have not been successful in planning any post-Weekend event for a given Weekend.

**Regarding Weekend costs**: We have received a couple of inquiries regarding Weekend costs. Besides the application costs going up to \$100, the <u>www.GodLovesMarriage.org</u> website says under "What is cost?"

The per couple value of your Marriage Encounter Weekend ranges from \$375 to \$515, depending on prevailing lodging and catering costs in each location. On Sunday afternoon of your Marriage Encounter Weekend, you will be given the opportunity to make a confidential free will contribution to help Marriage Encounter pay for the lodging and catering costs of your Weekend.

## <u>AREA</u>: Pennsylvania (continued)

Even though it does stress that their financial contribution is free will and financial circumstances should not prevent them from attending, we've gotten a couple of calls saying they can't afford \$600, so it makes us think this may be a factor in smaller number of applications.

We are not covering costs for Weekends so we totally get why it is necessary to make couples aware of expenses; however, it seems that we are caught in a Catch 22 that if we don't encourage larger contributions by letting them know the costs, we may run out of money; but if we publicize the costs, our applications may be down enough that we won't have enough couples to hold Weekends. Don't know what the answer is.

The other question regarding this is that the website says that their contribution is to help Marriage Encounter pay for "the lodging and catering costs of <u>your</u> Weekend" and tells them how to find the cost of their Weekend to budget for it. Meanwhile, the outline tells 3rd Set couples that we are to tell couples: "We aren't asking them to pay for their Weekend; we are asking them to sacrifice for the sake of other couples..." Maybe to avoid the contradiction, the website could say something less specific like: "...help cover the costs of Weekends so that Weekends can continue to be held." Just a thought.

**Regarding the upcoming changes in the outline:** Looking at the list of changes to be made, it appears that it is almost entirely cosmetic—just standardizing the Roman numerals, correcting a couple of errors where it says to refer to a section and then gives an incorrect section, and adding 5 minutes or so to some writing times, etc. So I think we need to stress that they estimate that noting the changes should only take an hour or so, and perhaps not call it the dreaded word, "re-writes" as there is no re-writing involved, and just the word "re-write" can cause some to decide to retire.

#### AREA GOALS:

We have scheduled 4 Weekends for 2016—2 spring ones and 2 fall ones. We decided to go ahead with the number we have been doing with the knowledge that we may have to cancel some with application numbers being down. We now have a Presenting Couple Coordinator in PA (the Wertzes) and are starting to train our other PA presenting couple (the Laceys) regarding the Lay Contact Couple job. We're hopeful that the 6 couples who did a mini-retreat last year will be able to plan another one this year. We met with 2 couples regarding presenting, but circumstances in their lives have prevented them from going forward at this time.
