- Pilots: Utilizing a combined spiral bound Workbook/Notebook; Self/Feelings swap (very well received-order makes more sense, timing works, latecomers can take inventory on own and don't miss the foundation of the Encounter Experience: feelings); providing a rough schedule of the Encounter (starting times only) for couples who request it (as a timeless experience is proving to be a distraction to an increasing number of couples); more efforts in personally surveying participants Post-Encounter.

#### **INVITING/RECRUITING/PUBLICITY BEING DONE:**

- Participation in Best Practices for Ministry Conference (AZ and IN). This is a conference attended by 2000+ forward thinking, missional church leaders throughout the country. (Dozens of interested pastoral couples shared their contact info for follow-up).
- Inviting/Publicity services offered by our Media Specialists include church mailings, website, and social media.
- Partnering with other Faith Expressions to publicize and hold Encounters.
- Local Area/District Efforts: church mailings; romantic dinners; inclusion of Pre-Encountered couples in Post-Encounter activities; 'temple talks;' posters in grocery stores, libraries, bookstores, etc.; LME booths at pastors' conferences.

#### **WHAT IS BEING DONE TO ENGAGE/SUPPORT THE NEWLY ENCOUNTERED:**

- Ministry Initiatives to provide personal connection, post-encounter activities, and to encourage commitment to ministry. (See NAR Initiatives Summary Attachment).
- NAR-wide Eblasts are emailed (to all encountered couples). They include a short video clip (can be used as a couple or in a Journey Group or other community activity), a sharing question, dialogue questions, and notices of upcoming events, ways to get involved, etc.
- Local Newsletters (vast majority are electronic) to keep folks connected, advertise community events, etc.
- A variety of Post-Encounter activities for couples and families along with Journey Groups continue to be offered throughout North America. Events offered include: enrichment workshops, cheese/wine-tasting events, camping events, picnics, holiday gatherings, Romantic Weekends/Renewals/Reunions, World Marriage Day celebrations, movie/date nights, Family Fun Days with picnic and hiking, and Road Rallies, Encounter Wrap-Up Gatherings.
- Many Areas are utilizing "Sharing Our Gifts" inventories to solicit involvement based on the couples' interests.
- Facebook Groups/Facebook Live presentations

#### **CPO ACTIVITIES:**

##### **District 1 (Eastern Time Zone US and Ontario and Quebec, CA):**

Central Area explored a lead to share a Weekend with the Mennonite-Brethren Expression in May in Ohio, but that fizzled. Personally, Fells are workshopping the Baptist Clergy, and our team stands ready to share an Encounter, and has a meeting with the state-leaders for WWME in June.

N.E. Area includes one UCC couple in CT as a presenter.

N.W. reconnected with the WWME expression locally, who joined in the Christmas activity and some Journey Group get-togethers.

##### **District 2 (TX, OK, LA, MS, AL, AR, TN, KY, IN, IL, MO, KS):**

Rockford contacted local Methodist ME leadership who were interested in advertising to their community (though they are not holding Encounters).

The Dallas Area Methodist spiral keeps us informed of their meetings and those of us that can make it attend. They are also kept apprised of our Journey Meetings and attend when they can.

Williams have attended Catholic Sectional meetings and have given their presentation on the four generation groups at a couple of Catholic leadership meetings. Interaction with the Catholic Community continues to be a source of resources, networking, and ideas.

#### District 3 (ND, SD, NE, IA, MN, WI, Saskatchewan and Manitoba, CA):

Methodist and Lutheran couples share in presenters/board meetings and assist each other as prayer couples. Several SDA couples prayer coupled and attended sing-off

#### District 4 (NM, AZ, CA, OR, WA, ID, MT, WY, UT, NV, CO, AK, HI):

CO: All Encounters, Journey Groups, meetings, etc. have been integrated with the UME group. Other Faith Expressions are welcomed.

WA: Catholic community is only other local Faith Expression they know of in Washington and Oregon at this time. Response to contacts has been minimal.

### **VARIETY OF MARRIAGE ENCOUNTER EXPERIENCES:**

District 1: Central Area offers to Encounter attendees and in print to churches, that we are willing to take the Encounter to locations outside N.E. Ohio, including non-residential Encounters, but haven't found any "takers" for 2 years. A 7-week 3RE Encountered has been offered to a church - they are considering it, after declining to host one last year.

N.W. Area is discussing the possibility of holding a non-residential Encounter in the future.

Southern Area is considering a pay-your-own for this coming October.

District 2: St. Louis is planning to possibly hold a clergy-only weekend at the Seminary.

Combined traditional and non-residential Encounter in D/FW in November at a small retreat center. Only 12 rooms are available but adequate space is available for presentations. This will allow us to offer rooms for those coming from a distance, while offering a non-residential opportunity for local couples. This will hopefully reduce cost and make the Weekend available to some who would not otherwise consider attending. D/FW will offer a Community Overnight Retreat for Encountered couples. The retreat will be held at the facility our November Weekend is scheduled for as a familiarization and dry run effort to work out the kinks before the Weekend.

District 4: Second RV Encounter is scheduled in Ten Sleep, WY on July 14-16, 2016. UME community they are partnering with is leading the way in hosting a 3RE Encounter in Thermopolis, WY this fall.

### **UPDATES TO SHARE:**

We have been offered an opportunity to outreach LME to India through connections with Lutheran pastors attending seminary in St. Louis, MO. The information concerning need and a proposal to move forward has just been received and will be taken to our North American and European Boards for consideration. The need for marriage education and support there is great and the cost will be significant. Your prayers are most appreciated.

- Experienced, supportive leadership at all levels
- Dedicated volunteers
- Up-to-date, professional Inviting & Publicity/Media web and social media presence with common 'branding'

**CHALLENGES:**

- Effective Inviting/Recruiting/Encounter Attendance
- Post-Encounter involvement / lack of greater community support
- Raising up new/younger leadership couples
- Dwindling number of Encounter Presenters
- Geographical distances
- Moving from a mentality of ministry survival to a mentality of ministry THRIVING!

**FAITH EXPRESSION PRAYER CONCERNS:**

- That God be honored in everything we do, say, and try
- Ministry leaders and volunteers – commitment, motivation, health, aging leadership, younger couple involvement
- Churches to promote and support the ministry
- Outreach & pilot Encounters
- Increased Encounter attendance
- Outreach to India

**WHAT TYPE OF HELP/IDEAS DO WE DESIRE FROM THE INTERFAITH BOARD?**

- Ideas to increase post-Weekend involvement – all ages; especially younger couples
- Programs to develop new, younger leaders
- Ideas to increase Encounter attendance

**IDEAS TO CONSIDER AT THE NEXT FOUNDATION MEETING:**

- Advertising blitz – radio, television, internet
- No Success without Successor and/or other personal leadership development opportunities
- Post-Weekend Surveys via Mail Chimp or Survey Monkey

**FINANCIALS/STATISTICS:**

- Significant reductions in overhead and meeting costs along with an increase in Post-Encounter donations has kept us financially viable.
