Introductions included names and where each lives. This tied in with the pre-meeting question asking each to share about a travel memory they have as a couple. Reflections on the stories were shared.

Minutes from the May 1, 2021 virtual meeting were approved with no changes.

#### Spotlight: Anna & Kari Alander – ILME Executives

Presentation by Kari and Anna Alander. The presentation included a PowerPoint about what has been happening in the European areas with ILME. Highlights included that there are 5 districts, 5 languages and 5 currencies. The official language is English, to make things more consistent. They cancelled all weekends in 2020, due to the pandemic. Finland did an online experience over 4 nights, 3 hours each night. They hold online Love Circle that is open to all and have 10 to 25 couples participating. They hope to have in person weekends in Fall of 2021. Some adjustments they are doing include shortened presentations and earlier ending on Sundays. It is up to each district to approve adjustments. Finland has plans to pilot a non-residential weekend soon. They follow the European Catholic outlines. They now have their outlines on a shared server.

#### **APP Committee Report**

Leah Cole reported for the app committee. She stated that there is no big news right now. They are each working on various parts and hope to have more at the next meeting. They are still working to find students to help, through the Lutheran colleges.

#### **Staff Reports**

Finance – Report by Dean Redman

Reports are included in the attachments. We no longer have district finance couples, which means everything goes directly to Dean. This has made things simpler. Stock market gains have helped the Dream Fund grow. He is considering moving more to Thrivent, but it involves a lot of paperwork. There have been 3 virtual weekends so far in 2021.

Media – Craig and Connie Leinicke were traveling. They attempted to call in, but did not give a report.
