

#### **Marriage Encounter Outline Committee Report**

We thank all of you who submitted suggestions for the next revision of the Marriage Encounter Outline. As we said, outline revisions are not planned for the immediate future, but the Worldwide committee met for a weekend in November, and Tony and Cathy Witczak have furnished us with the following report of that first meeting:

"We were very pleased with the first meeting of our Outline Committee. Seven couples and four priests from the first tier of the committee gathered in Newark for this effort, and it was obvious as the weekend progressed that the Holy Spirit was there as well. We represented the main cultural groups in North America and a diversity of years encountered, and all of us were understandably anxious about how to approach this daunting task. Yet we were able to move forward together with very little disagreement. This was in part thanks to the direction of our facilitators, Scott & Karen Seaborn and Fr. Mitch Walters, but it was also because of the prayerful attitude of openness that prevailed. We thank all of you who were praying during that time and we ask for your continued prayers as the work continues.

At this time there is very little to report other than that we are looking at the outline to determine if we can eliminate redundancy and identify things that don't add value. One of the goals is to shorten both Friday evening and Sunday afternoon to accommodate the needs of today's couples.

We also hope to update and improve our weekend by looking for a different transformation story and by considering the use of modern technology. There have been many requests for greater emphasis on the call to be open and apostolic and we hope that the outline that evolves will address that need also.

We will continue to meet via conference call. Another face-to-face meeting is planned for the summer of 2009. After that, we may have more to report and to share with the second tier of the committee. The second tier has many couples & priests including couples from the Interfaith board. They will give direct feedback on the work of the first tier as it evolves. We are sure that using this collaborative process and relying heavily on prayer, we will come up with an outline that meets the needs of our times while still holding true to the core values of our movement. We hope this helps. Thank you for the observations you sent. We all appreciated the efforts of those who took the time to write their suggestions as they helped to guide us in this project!

### Minot, ND Outreach Weekend

"Minot or bust" was the prayer of District III. Minot had been in many prayers for a whole year!

The request for an outreach to Minot, ND, began in the spring of 2007. Pastor Paul Krueger from Minot, in collaboration with Pastors from 5 churches (2 Missouri Synod, 2 ELCA, and a Lutheran Brethren Church), was doing a series on Strengthening Marriages and he wanted a Lutheran Marriage Encounter weekend to be the culminating activity. Pastor Krueger and his wife had been on a ME weekend many years prior and knew the value of a weekend.

A concern began right away with the request that communion not be served on the weekend because of the mix of church synods involved. Brainstorming ideas of a way to include all the affiliations, it was decided that the weekend could go ahead if a ME presenting clergy couple would be willing to do the weekend without the Sunday communion with the couples. That decided, we began to go ahead with the planning for a weekend.

In April of 2007, Doug and Leanne completed their term as District III Lay Contact and passed the baton to Dean and Marcia Redman. Planning continued and a date was set for a weekend in April 2008. The initial count Pastor Krueger anticipated for registrations was 20 - 30 couples, and when registrations were only 6 by the deadline date, the weekend was cancelled. Thanks to the encouragement from the NAR board in July 2008 and the continued prayer, it was decided in District III that the weekend would be rescheduled for fall and it would be held regardless of the number of registrations. With the commitment of Dave and Elsa Larson, Lincoln, Nebraska, Clergy; Doug and Leanne Fox, Bassett, Nebraska; Milton and Donna Kaufman, Wilmont, SD; and Dean and Marcia Redman, Milwaukee, Wisconsin, the weekend was rescheduled for Nov. 21-23.

A true commitment to the Marriage Encounter ministry it was! Holding an outreach weekend with no contact couple there took many phone calls, many emails, much preparation, lots of organizing and many prayers - and great flexibility within the presenting team. Pastor Krueger secured the hotel at a wonderful rate, and then the work of getting late check out, no housekeeping, etc., etc., needed to be conveyed. The hotel rooms and the dining contracts were with two separate contacts and it was at times difficult coordinating until the final contracts were ready. We were on a total leap of faith that the hotel and food were good. Vern and Karen

Harrington in lowa agreed to act as registration couple for the weekend and they kept all informed as registrations by snail mail or internet came in. Although Harringtons like to be at the hotel for registering the couples, time and distance prevented that, the presenters were to act as the registration/hosting couples. One amusing story - Dean and Milton were sitting at the table talking as couples were coming into the hotel. With the ME banner "love one another" proudly displayed beside them we all had a good chuckle and decided maybe it would be better if a husband and WIFE sit there together. Sadly, about 3 weeks before the weekend, job responsibilities kept Doug and Leanne from presenting on the weekend. However, they continued to support the weekend as they did all the work to gather long-distance prayer couples and sharing letters. It was so heartwarming with the quick response of prayer couples and the huge amount of sharing letters that each couple and presenter received.

Supplies and various weekend materials all had to be brought in. Larsons packed their car with the clergy materials and drove 6 hours to Kaufmans in SD. Then they repacked one vehicle with the weekend banners, individual room banners Donna made, table supplies, table graces and song sheets and many more incidentals and they drove together the remaining 6 hours to Minot. Redmans packed a *heavy* suitcase with the notebooks, spirals, and candles for each couple, and boarded the train in WI for their 900 mile ride. Excitement propelled us all on as the fruits of our labor and the answer to many prayers were so close!

Ten couples were in attendance on the weekend--ten loving, warm, friendly couples who seemed to have a great weekend! One couple was a true testament to unconditional love to all. They both had vision problems the wife was nearly blind and the husband had very low vision issues - but they completed the weekend. The very loving husband would find the page in her workbook and when it was time to write he would turn her notebook to a blank page and she would begin to write. Donna Kaufman also took great care of her as she helped her get to and from the room when wives left. Team discussed how extended dialogue would work and it was decided Marcia Redman would go with her and "Mary" dictated all her thoughts and feelings. A unique experience for all!

Distance prevented all of the presenters from coming back for a weekend renewal or support for love circles. There was much discussion about how we could convey the renewal and love circle information with the journey talk, but with all of us working together all the information was given to the couples. The packets each couple got were a collaboration of the different areas as we all included information we usually put into our packets so the couples went home with a lot of information to help then with dialogue. We are all only a phone call or email away and they were told that, and it was reconfirmed as we all called and wrote letters to each of the couples after the weekend.

A wonderful little Godsend occurred 2 weeks before the weekend. It was discovered that there is an active Catholic ME community in Minot. They actually had had a recent ME weekend. Redmans were able to make contact with the key couple in Minot and they came to the sing-off to meet the couples. They invited the couples to join their love circles and volunteered to help any couple form a Lutheran love circle if they desired. The Lutheran couples were surrounded in love even in the Catholic community.

It is our prayer that next spring there will be another Minot weekend. We did tell the couples we would all come back again, but they needed to do the legwork to get it all going. There were a lot of smiles and nodding. We will keep praying!



## PowerPoint Slides for Synodical Meetings


