WEEKEND QUOTE

It has been called to our attention that there have been some questions about the Weekend quote. Following is an explanation of how the 3rd Set couple knows what figure to use for the Weekend Quote. To find your quote, find on the chart the Weekend per-couple expense (This should include all taxes, gratuities, and meeting room, but NOT the presenter expenses--Those are to be covered in the \$175 per couple overhead.) and add \$175 to the corresponding part 2 figure. (Whenever possible, try to have the hotel give you an ALL INCLUSIVE per couple cost for the Weekend as this will save you a lot of headaches trying to figure out how much needs to be added to the per couple quote for such things as taxes, gratuities, conference room, etc.)

3rd Set Couples: Be sure you have a copy of the following sheet with you at all Weekends presented.

How does the Admin Couple know what to ask in the Weekend Quote?

In Aug 03, the NAR board adopted a new system for calculating the Weekend Quote, based as usual on the total cost of doing LME business divided by the number of couples encountered, but then including a weighting figure based on the facility costs. It was not intended to expect that each Weekend "pay for itself" - LME is family. Below is what was approved: The weekend quote will be determined individually for each weekend and will be the sum of:

PART 1

A fixed amount covering LME's proposed overhead budget: \$175.00/couple (per the NAR Finance Couple)

PART 2

An amount to cover the cost of the facility. This amount will be based on the facility contract per-couple cost (including tax) as shown in the table below.**

Weekend Quote

Weekend Quote = Part 1 + Part 2 (see following table) It is the responsibility of the Area Lay Contact Couple to insure that the contract per-couple cost amount is provided to the Third Set Couple prior to the start of the weekend.

If the per-couple weekend amount should be greater than \$350 per couple, please consult with the District Execs before committing to the facility. If they approve they use of the facility, part 2 would increase by \$25 for each \$25 range increment in the per-couple cost. For example, if a per-couple cost of \$380 were approved by the District Execs, the weekend quote would be \$565 (\$175+\$390).

Note: Only the weekend quote amount will be mentioned on the weekend, <u>not</u> the individual components or the method of computation.

- The Contract Cost per Couple is simply what the hotel quotes to you on what they will charge each and every couple on the weekend for the "weekend package" of food + rooms.
- It has nothing to do with the <u>number</u> of couples on the w/e (If you have agreed to a sliding scale that does affect the per-couple package cost, you will choose the appropriate figure).
- The presenters' costs are already part of the Part I overhead.
- It includes all taxes per package.
- Any additions? Let's say you pay a flat fee of \$200 for the conference room. Or \$50 one-time room set
 up. Pots of coffee? If so, try to add an average for these additional costs to the per-couple package. This
 isn't meant to be nuclear science, just a practical way to ask for more when costs are more.

Iceland

Edda ML Laugarvatn Hotel

The 2010 LME Family Reunion will be held in Iceland June 25-27 starting about 3 p.m. on Friday. The website www.ilme-iceland2010.com is up but still under construction. Other websites of interest are the Laugarvatn site: http://www.nat.is/travelguideeng/laugarvatn.htm, and the Iceland Tourism Board site: http://www.icelandtouristboard.com. The location is Laugarvatn, 57 miles / 1½ hours out of the capital city, Reykjavik. Kids are welcome. Transportation from Reykjavik will be provided. The organizers of the event are: Gunnar & Thora at gunnarthora@simnet.is. Presently they believe the per couple cost for the reunion will be approximately \$510.

According to the website: the hotel is situated in Laugarvatn, a small village with a population of approximately 200. The hotel has 99 rooms -- 32 with en-suite bathrooms and 67 with inroom washbasins, so those who register early will have the better accommodations.

It is in the heart of the countryside of South Iceland and is a good base for touring the "Golden Circle" -- a triad of Iceland's most popular natural wonders: Mighty Gullfoss Waterfall (18 miles away), Geysir hot springs (12 miles), and Thingvellir National Park, ancient site of the world's first parliament (15 miles).


Current plans are for the NAR summer meeting to be held in Iceland the 3 days following the Reunion, June 27-29, 2010.
